FORE PILLARS OF CIVILIZATION

In a world where in two lifetimes the population has exploded from one billion to eight billion; where specialization exceeds the comprehension of any single person; and human perception of this world is on a continuum where no two people view it exactly the same, in order to achieve a Civilization a common Moral Code must exist. That which is offered here is based upon a moral code where each of the many participating individuals accepts that each individual is equally endowed with sovereignty over one's person, property and minor children. And with very few exceptions, the mission of government is to produce, provide, protect and preserve this sovereignty of each individual. By so doing, governmental institutions enable the sovereign citizens to interface in a free orderly manner.

Governments have taught their populations to look to government to provide for their well being. This is beyond the ability of government so as a result we find mobs of unruly citizens in the streets protesting the failure of governments.

The Institute of Perceptionism® has indentified four essential and interdependent pillars of civilization. These, are describe here and are further developed in writings at Perceptionism.com.

PILLAR ONE <u>The Nuclear family</u>

Where ever on Earth, the evolution of humanity *over some ten thousand generation* has created the Family as the foundational building block of all successful human social structures. As the human incubator, the Family has evolved to provide: the essential Mothering of every human being; the psychological maturation of the well adjusted person - a role for which the Father

is essential; language -the operating system for the brain; the child's socialization and civilized behavior - manners, etiquette, respects for elders and the hierarchy; foundational education – an understanding of one's environment, economic wellbeing – food, clothing, shelter, healthcare, education, transportation, communication and recreation. Also, the Nuclear Family is responsible for the basic care and compassion of its elder members. Offered below are institutions that strengthen the role of the elders in the family. It is inescapably, the incubator of the human being that starts before birth and lasts for some twenty to thirty years. If humanity has any value, that of birthing and nurturing of a child for these earliest years are the most critically important and valuable a woman shall ever have.

Government has not been able to successfully perform these functions. Government policies ha have degraded and dishonored Motherhood to the destruction of the Nuclear Family. The Nuclear Family has deteriorated significantly over the last fifty years. The consequences of this have been a crumbling of other three pillars of civilization. PERCEPTIONISM® offers some tools for repairing this damage. (see Perceptionism.com) New institutions such as ones that merge broken families with others in different ways must be sought. Those who choose to raise Children, must be prepared emotionally, educationally, and financially to make a two decade long commitment to raising each child. Because of the importance of a near 24/7 commitment of the mother to the first three years of an infant's life, social and economic institutions must be styled to accommodate her productive years before and after such a commitment.

The Nuclear Families will successfully be repaired or an ever evolving civilization will be lost. Suggestions for repair are disclosed below.

To this end, we propose a Responsible Procreation Amendment to the Constitution similar to this: Irresponsible Procreation is totally incompatible with a Free-orderly society. This compromising of individual sovereignty is essential to the existence and a positive evolution of humanity in a free-orderly society. If Humanity has any purpose or value Responsible Procreation is the highest achievement of most human beings. This is to assure that every newborn starts life with at least two competent contractually committed adults. To procreate without the willingness and ability to nurture and rear a child is to assume an authority without the commensurate responsibility which is, for the newborn, the rankest form of child

abuse. Inadequate parenting produces adults having debilitating psychological problems.

The evolution of the Human species in the nuclear family has imprinted this structure on the human brain and psychological behavior. The dishonoring of this fact manifests itself in the gross erratic antisocial behavior.

Therefore, we propose that the government shall issue a Permit for each baby intended to assure the every baby will go to its new home with at least two competent adults who have entered into a Family Contract to mutually and severally nurture, educate, and provide a loving, caring, developmental environment until adulthood. This requires that a mother must have the singular occupation of mothering each child for its first three years of life. Each partner of this Family Contract will have attained some minimum level of competence in order to qualify for a Permitted Child. Qualification will require certain educational achievements for the skills of a functional family, the bearing and nurturing of children and the occupational skills necessary to support the family. At least, one member shall be engaged in productive activity that enhances the human condition, demonstrating a justification for their replacement. Entered in to, as sovereign individuals, the Family Contract, enforced by the States, shall stipulate all of the terms and conditions of the relationship including a procedure for dispute settlement – effectively, the Family Constitution. The Family Contract shall constitute the nature of the human nuclear family such that the Word Marriage shall henceforth be null and void in all laws, statutes, regulations and rulings. Those who parent a new borne not having a Permit shall be sterilized.

Marriage shall be relegated to religions.

If reverence for human life is to be preserved, conception and birth must be looked upon as life's fulfillment for the years of self-denial and forbearance necessary for the joy of achievement by competently nurturing, rearing, and educating a child for a productive role in society.

In a society where all receive sufficient income for survival, only those couples having a genetic propensity to be engaged in a productive occupation shall have the permission to procreate. Persons with no contributory role need not be replaced.

The significance of the evolutionary role of each gender in the psychological development of a child will likely be discernible at a time after different family structures have the experienced in the several states. Combined with PETAs, Responsible Procreation will rapidly diminish social welfare program.

PILLAR TWO A Universal Moral Code

Religious Philosophy provides the human being tools for dealing with the unknown, the death dilemma, direction, purpose, value and a foundational moral code. Without a universally accepted and practiced Moral Code there is no civilization.

Because traditional religions are taught from infancy, they become indelibly part of one's mental processing for most people but not all. Where traditional religions have become inconsistent with human understanding of the universe for some, rejection of traditional religions has left them with void of purpose, direction or moral code. The default moral code is Might makes right or the end justifies the means.

The Institute of Perceptionism® offers a belief that "sovereignty rests with each adult human being over his/her person property and minor children" not with a Governor, King, Emperor or any government. As did the Founders of the United States when they understood the Liberty meant liberation from the sovereignty of the King's government and declaring that all men were equal to the sovereign king so thereby sovereign over themselves. To whatever degree your sovereignty rests with someone else you are their slave. Sovereignty requires that while total authority rests with the individual, total responsibility must be assumed. Authority and Responsibility are inseparable for if responsibility were to rest on another without commensurate authority they would be enslaved.

As the sovereign people interface with one another they must do no harm without reparation.

This tenet of self-reliance provide a simple, easily understood moral code as it requires that **each sovereign individual do no harm to any other sovereign individual without appropriate reparation**. This provides a moral code that is compatible with most traditional religions as they can be practiced while honoring this tenet. This self-reliance and personal sovereignty is also the very essence of Liberty and Freedom.

PERCEPTIONISM® in its

PILLAR THREE Government

In a liberated world, where government is not the sovereign, sovereignty is vested in each individual and not in government; a concentration of corrosive power can be avoided. The government's primary role is to honor, protect, provide and preserve the sovereignty of each adult human being. Sovereignty means total and absolute life and death authority over and responsibility for one's person, property and minor children with the only exception of those presented here.

With the implicit consent of those sovereign persons who choose to live in this civilization, Government is granted the power and responsibility to provide and enforces the "rules of the road" and other essential rules by which sovereign individuals can peacefully, orderly, amicably and productively inter-face with one another.

Government shall create institutions where sovereign individuals may have voluntary orderly social intercourse. It shall provide Courts and arbiters for the resolution of conflicts, harm or damages that occur between and among the sovereign persons.

Persons who intentionally inflict harm or cause damages to other, would be sent to behavior modification for a first of even second conviction by the judge Third such conviction will have a mandated sentence to leave the country and never return of put to death. Any country that complained needs only to send a visa. A country that Grants a murderer a two million Dollar Life Annuity – the cost of life in prison is too conflicted to survive.

This makes unnecessary all manner of statutes, laws and regulations governing human conduct.

As children are commonly taught and as adults forget, "Mind your own business" not that of other's will end all manner of legislation

Government shall enable and foster Rating Services to replace the free market inhibiting Business and Professional licensing admission limiting associations and accreditations. Government shall not engage in activities that can be relegated to non-government entities. For example, beyond establishing the rules of the road and the physical characteristics of the highways, with the electronic ability to toll highway use, The interstate system and its feeders can be divided into rational market segments and be placed in non-profit organizations governed by representatives of the cities, counties major business entities contiguous and having a local vested interest in the tolls and capacity of that segment. This could disburse control of all the highways to over some six thousand persons employed by those representing the major stake holder of that segment of roadways. By minimizing the power of those who govern, corruption will also be minimized.

The administration of the FAA rules can be administered by an independent entity representing and paid for by the stake holders in air traffic control. The FDA could be replaced with a mutual insurance company where all producers and marketer of drugs underwrite all harm or damage to any one as a result of ingesting their legally acquired drugs. This would include any side effects. A free market for human organs would end any cueing for transplants. Such a mindset can avoid the corruption caused by concentrated power. In these ways, great power can be defused over thousands of non-government persons. No government regulators may be controlled in any way by the controlee. Those who have been Government employees may never be employed by controlled entities.

Government shall foster the creation of volunteer and charitable institutions to provide for matters of care and compassion.

The control of Government must be limited to "Left" brain-rational thinking. Government cannot successfully engage in "Right" brain matters of care and compassion as these are without limit and beyond the capacity of government and axiomatically requires the involuntary participation of some to care for others – a form of slavery as some sovereign persons become coursed in to providing care for others.

Because "right brain" – caring and compassionate thinking and "left brain" – critical thing ability are generally uneven among and between the genders but equal among some, a "left brain critical thinking quotient" would be helpful in the selection persons for government. As we know now or will learn eventually, care and compassion exceeds the capacity of government to provide.

We have identified three evolutionary human characteristics that are incompatible with an orderly society that must be constrained by government mitigating individual sovereignty to this extent. Also, there will be temporary encroachments as society transitions to the new prosperous, free, orderly society Therefore, the sovereign persons, by remaining in this society, shall have tacitly consented to this government encroachment on their sovereignty.

First Exception Any power over any persons or capital assets granted or obtained by an individual will influence him/her to think of how to use it to improve their personal wellbeing preempting the intended purpose for one's having the power. To deal with this corrupting Human nature, government shall style institutions private or public that govern people to function with greatly defused and a minimal power vested in any one individual by distributing it among many. Penalties for the misuse of power must be effective.

Second Exception Human evolutionary designed sexual behavior is frequently in conflict with the requirement of an orderly civilized society. In as much as the Nuclear Family is paramount, irresponsible procreation shall not be permitted. In order to better assure that each human being deserves and has a sound developmental environment, government shall issue Permits for each child to become part of a competent Nuclear Family.

If those who bear a child without a Permit or an adoptive family were to be sterilized - including the father the pool of adopting parents would grow larger,

Government shall seek ways to tame, mitigate and civilize the human libido.

Evolution has also created a couple of human characteristics that are frequently destructive to the Nuclear Family. <u>Promiscuity</u>, which manifest as pursuit of the excitement of the unconditional response, was a result of promiscuous persons procreated much more frequently than monogamous persons. Male <u>Sexual Fixation</u> resulted from older men who were fixated on young females procreated more frequently than those who were not. These innate characteristics cannot be denied or ignored.

Third Exception The forbearance of current consumption and saving for the future needs, while not natural to most, is essential for all to have a Free, orderly, durable ever improving economic system. A Government institution can establish a rate of return on required saving by individuals that will produce sufficient funding of the capital requirements for a rational growth rate of the economy.

The Institute of Perceptionism, proposes some institutions toward achieving this end. The most significant is the **Personal Estate Fixed Investment Trust Accounts** (**PEFITA**)

that will eventually replace Social Security and the multiplicity of safety net programs as everyone will have sustaining passive income. For a clearer understanding, our Proposed Amendments to the Constitution are disclosed in our White Papers. These principles can be adopted by any government.

The Personal Estate Fixed Investment Trust Accounts (PEFITA) provides the mechanism that allows the economy to achieve and equilibrium balancing of the supply of capital investment and the demand for capital investment. It overcomes the human failure to forgo immediate gratification to provide for future needs and growth of one's future economic wellbeing. And it is a significant institution for reducing the disparity of wealth and income. To overcome this human innate frailty and still achieve a Free-Orderly Durably Prosperous Society, this mandatory PEFITA compromise of individuals' sovereignty is essential.

The PETAs becomes the most significant institution serving the axiom: that for an economy to achieve a durable growing state, "That, which the land and capital assets earn must flow, as nearly unencumbered as possible, to the

consumers of their production." The ever increasing sovereign debt, corporate debt, personal debt and the ever increasing fictitious value of assets is the process that has filled the gap between that which Land and Capital assets earn and that which flows back to the consumers of that which they produce. This recognizes the folly to believe that the gap between that which the capital assets and land earn and that which ends up in the hands of the consumer can be made-up forever with the creation of feaot money and other fictitious asset. This, almost universally over looked fact, is the most fundamental element of either having a stably growing economy or a Boom and Bust economy

The **Personal Estate Fixed Investment Trust Accounts (PEFITA)** will be established for each and every living person with a Social Security number. The Personal Estate Trust Account may be directed by the owner but must have all of the following elements:

The **Personal Estate Fixed Investment Trust Accounts** s can only be transferred by gift or bequeath to another PEFITA or to a not-for-profit Trust having the same investment and transfer limitations for funds not distributed to consumers.

The Personal Estate Fixed Investment Trust Accounts s may only invest in common shares that can never be liquidated or in Fixed Trust the holdings of which may never be liquidated, managed by traditional asset management companies, which hold only common share that can never be liquidated. No newly purchased common shares of any single issuer may exceed three percent of the PEFITA's holdings or the holdings a PEFITA eligible Fixed Trust. This would apply to PEFITA gifts or bequeaths received by Non-profit charities. The PEFITA holder shall determine the investment within these parameters. The PEFITAs eligible Fixed Trust shall be invested across the spectrum of investment objectives commensurate to the relative market demands for capital. This shall not apply to shares acquired as "incentive" shares.. All of the net earnings of the PEFITAs after expenses must be distributed regular intervals to the registered account holder.

The **Personal Estate Fixed Investment Trust Accounts** s shall replace payments to Social Security (SS) as it transforms to a Mandatory Savings institution. As the major supplier of investment capital for the economy, the rate of required savings will be adjusted higher or lower by the Federal Reserve based upon the demand for

capital investment. The equilibrium of demand for investment funding and the supply of funding provided by the PEFITAs will become manifest as the dividend yield on the PEFITAs. The Federal Reserve will adjust the amount of savings higher or lower to maintain a composite dividend yield of five percent.

So structured, the PEFITAs will assure that the PEFITAs will grow with the economy from generation to generation ever raising the accumulated wealth across the population over riding human nature's inclination for short term gratification. Any lesser restraints would assure their destruction. The fifteen percent of employee's earnings now dedicated to Social Security will now be a "forced savings plan" eventually replacing SS as it provides the capital investment for the growing economy. This will create a constant balancing of consumption and capital investment.

To whatever extent the terms and conditions expressly provided here fall in to the purview of the Congress, they will be perverted and corrupted to dysfunction.

The current fifteen percent or so of an employed person's production is allocated to SS. Had those funds been invested in PEFITAs and Fixed Trusts since 1936, beneficiaries would be receiving far more, after two or three generation of accumulating wealth, than they are currently from SS. The SS structure could be modified in a manner that would cause it to morph or transform in to a system of required deposits to PEFITAs solely. This would provide the capital requirements of the economy as the required rate of savings deposits will be adjusted higher or lower to maintain a yield of equal to 5% + the (secured) loan default rate + the inflation rate. As the PEFITAs become the main supplier of Capital investment, when the demand for capital investment rose above equilibrium, the yield rate of return on PETAs would rise above the desired rate of return. To acknowledge and accommodate this greater capital demand, the rate of required savings contributions would be raised to maintain the supply of Capital in equilibrium. At a time when capital needs were lower, the reverse would be imposed.

Individuals and families will, over time and generations, become ever more financially sound as their forced wealth accumulates and their resulting personal incomes grow. Existing Safety Net programs will gradually be replaced by the income from the PEFITAs.

The purpose of the PEFITA is to distribute the earnings of capital assets to consumers and do so while assuring the ever improving financial wellbeing of all. Making markets in such holding would only engage many people in non productive activities. Extensive diversification will cause the winners and losers to be evenly distributed.

The USA will successfully repair its corrupt coercive government or it will totally lose any vestige if freedom or liberty.

PILLAR FOUR The Economic System

The Economic System offered here is one of PERPETUAL GROWTH.

This Economic System - PERPETUAL GROWTH solves the Faial flaws of our present day concepts.

Marxism's fatal flaw was that It required that great power be given to a few human bings the always became hopelessly corrupted and the system always became dysfunctional.

Capitalism's fatal flaw was its dependence on the ever increasing creation of fictitious assets to make up that portion of the earnings of the capital assets that did not flow back to the consumers of that which the capital assets produced.

A PERPETUAL GROWTH economic system honors the sovereignty of each individual over one's Property. In doing so there is no income tax. Income Tax shall be replaced by excise tats, value added taxes and use taxes. The role of government will shrink to a small fraction of present day government.

Capital is provided by personal savings invested in equity shares of the corporations not by debt that is not secured by tangible assets. Therefore, excluding market makers, debt certificattion not secured by tangible assets is prohibited. Excluding debts to finance tangible improvements, and new resident home owners, it prohibits the extension of the debt burden beyond the maturity of its original indebtedness.

These measures will force a change in the ownership of capital assets from great concentrations of leveraged wealth to a much broader, inclusive ownership. Capital investment shall be supplied by forced and discretionary savings which shall be adjusted to provide the required capital investment to maintain a durable growing economy. This will force the sharing of the benefits of ownership.

This assures an ever increasing accumulation of generational wealth.

Beyond a reasonable retention of earning for capital improvement, corporations will be required to disburse the net earnings as cash dividends for through this system that which the capital assets earn will flow to the consumers of what the capital assets produce. There will be no Stock Buyback and all corporations shall have Preemptive Right protection.

Institutions that enable individual ownership beyond that offer shall be encouraged. Institutions that foster personal savings such as Credit Unions, Savings & Loans and equity investing are promoted.

Effective incentive plans that encourage and reward creativity, productivity and long term success are absolutely essential and by being rewarded by sufficient shares place in one's PEFITA it will be assured.

Accessible competitive market places where meticulous attention to an honest, complete disclosure of risks and pricing and matters that some buyer might find objectionable such as produced with child labor shall be assured by government.

This means that each merchant, professional service provider shall publish and disclose the price of the service or product offered prior to the transaction.

PERCEPTIONISM® in its entirety will produce an economic system which will provide humanity a durably constantly growing economy - avoiding booms and busts; one which distributes wealth to all of the people. Wealth is distributed consistently with nature, reflecting the wide range of human activities, human abilities, human ambition, human inclinations and the capriciousness of good and bad fortunes; and It will fulfill the presently eight human needs, food, clothing, Shelter, health care, education, transportation, communication and recreation for

all. Equality beyond a societal grant of individual sovereignty appears no place in the Human condition.

As a disorderly society transitions to a n orderly society there will be many who need assistance with the basic needs. The government providers of assistance shall disburse only to Approved guardians.

WARNING!

Humanity will learn of and live in a Civilization of a self-reliant, critical thinking dominated population similar to that posited here or human advancement will cease and will take on the nature of an ant hill or bee hive.
